REGULATIONS

1. Citation and commencement – (1) These Regulations may be cited as the Trustee Companies Amendment Regulations 2019, and commence on the date they are signed by the Head of State.

2. Regulation 4 amended – For regulation 4(1) of the Trustee Companies Regulations 2018 substitute –

"(1) For the purposes of section 32(2) of the Act, accounting records are to be kept pursuant to section 113 of the International Companies Act 1988, section 79A of the Trusts Act 2014, section 46 of the International Partnership and Limited Partnership Act 1998, section 39 of the Foundations Act 2016, section 21 of the Segregated Fund International Companies Act 2000 and section 58 of the Special Purpose International Companies Act 2012.".
